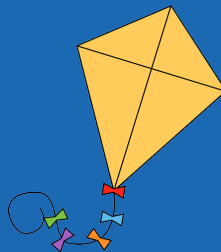

COVID Booster Mandate & Sick Leave

Dear Crew Mates,

We want to thank you for your continuous perseverance and adaptability as we continue to navigate the ever changing mandates regarding Covid-19.

On December 22, 2021 there was a new public health order (PHO) issued by the California Department of Public Health mandating COVID-19 booster shots. Regional Centers Statewide have received notification from the Department of Developmental Services (DDS) now mandating the COVID-19 Vaccinations and a booster shot for all Regional Center service providers, no later than **March 1, 2022** (previously Feb 1). Please see the attached for more information. All employees will be able to upload the required documents to "Crews Quarters" in Sandata.

Supplemental Paid Sick Leave has also returned in 2022. As a reminder, supplemental paid sick leave is an additional bucket of sick leave to draw from when you miss work due to COVID related reasons. This sick leave is retroactive back to January 1st, 2022 and expires September 30th, 2022. If you used regular sick time in 2022 due to the listed COVID related reasons (see attached), that sick time will be returned to you and instead taken from this new bucket. How much Supplemental Paid Sick Leave you have depends on your employment status and regularly scheduled weekly amount of hours.
